ARTICLES OF INCORPORATION FOR WOMEN'S IN LITH PRODUCTS, INC.

96 HAY - 6 PH 2: 54

ARTICLE 1 - NAME AND PRINCIPAL OFFICE

The name of the corporation is Women's Health Products, Inc. The corporation's principal place of business and its mailing address is 1112 Weston Rd. #135, Pt. Lauderdale, Fl. 33326.

ARTICLE 2 - DURATION

The corporation's duration is perpetual.

ARTICLE 3 - NATURE OF BUSINESS

The corporation organized to transact any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE 4 - SHARES

The corporation has the authority to issue 1000 share: at .01 par value.
