**ARTICLES OF INCORPORATION
OF
CONSUMER CARPETS AND BUILDING IMPROVEMENTS, INC.**

THE UNDERSIGNED for the purpose of forming a corporation under the Florida Corporation Act, does hereby adopt the following articles of incorporation.

**ARTICLE I
NAME**

The name of the corporation is **CONSUMER CARPETS AND BUILDING IMPROVEMENTS, INC.**

**ARTICLE II
DURATION**

The duration of the corporation is perpetual.

**ARTICLE III
PURPOSE**

The general purpose for which the corporation is organized are:

- a. To act as a contractor for the construction, repairing and remodeling of buildings, public works of all kinds, and for improvement of real estate, and the doing of any or all other businesses and contracting incidental thereto, or connected therewith, and the doing and performing of any and all acts or things necessary, proper, or convenient for or incidental to the furtherance of carrying out of the powers or purposes herein mentioned.
- b. To transact any other lawful business for which corporations may be incorporated under the Florida Corporation Act or engage in other trade or business which can, at the option of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

c. To do such other things as are incidental to the foregoing or desirable in order to accomplish the foregoing.

ARTICLE IV CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is One Hundred (100) shares Class A Stock. The par value is \$1.00 per share.

ARTICLE V INITIAL REGISTERED OFFICE AND AGENT
