I, the undersigned, make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be **SILVER & GOLD ENTERPRISES, INC.,** and the corporate mailing address shall be Hodusa Tower, 28870 U. S. Highway 19, Suite 408, Clearwater, Florida 34621-2564.

ARTICLE II - PURPOSE

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III - CAPITAL STOCK

The amount of capital stock authorized shall consist of 7,500 shares of common voting stock having a par value of \$.001 per share payable in lawful money of the United States of America or in other property, tangible or intangible, in labor or services actually performed for the corporation or stock, at a just valuation to be fixed by the Board of Directors, or issued as partly paid when so ordered by the Board of Directors. The capital stock of the corporation may at any time be increased or decreased as provided by the laws of Florida.

ARTICLE IV - EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved according to law, commencing upon the filling of these Articles of Incorporation with the Department of State, State of Florida.

ARTICLE V · INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is Hodusa Tower, 28870 U. S. Highway 19, Suite 408, Clearwater, Florida 34621-2564, and the name of the initial registered agent of this corporation at that address is DENNIS L. REPKA.

ARTICLE VI - INCORPORATOR

ARTICLE VII - OFFICERS AS DIRECTORS

All officers of this corporation may be directors.

This corporation reserves the right to amend, after, modify or repeal any provisions contained in these articles of incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
