**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
ELECTRICAL MOTOR SERVICES, INC.**

ELECTRICAL MOTOR SERVICES, INC., a Florida corporation (the "Corporation"), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation filed on May 6, 1996 (Florida Division of Corporations Document Number P96000040247), are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

"ARTICLE I

Corporate Name

The name of this corporation is TAW ORLANDO SERVICE CENTER, INC."

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.
