

#### ARTICLES OF INCORPORATION

# STARTIME MANAGEMENT & PRODUCTIONS, INC.

OF

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

# ARTICLE I - NAME AND ADDRESS

The name of this corporation is **STARTIME MANAGEMENT & PRODUCTIONS, INC.** and its business address is 100 N.E. 84th Street, 2nd Floor, Miami, Florida 33138.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles.

#### ARTICLE III - PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

#### ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation has the authority to issue is Nine Hundred (900), all of which shall be common shares with a par of One Dollar (\$1.00).

#### **ARTICLE V - PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

### ARTICLE VI - INITIAL REGISTERED AGENT AND OFFICE

STARTIME MANAGEMENT & PRODUCTIONS, INC. desiring to organize under the laws of the State of Florida with its principal office as indicated in the Articles of Incorporation at 100 N.E. 84th Street, 2nd Floor, Miami, Florida 33138, has named MARC S. SCHILLER located at 100 N.E. 84th Street, Miami, Dade County, Florida 33138, as its agent to accept service of process within this state.

#### ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have four (4) Directors initially who shall serve until his or her successors, if any, are elected at the shareholders' annual meeting. If and when so permanently constituted, the number of directors of the Board of Directors of the Corporation may be either increased or diminished from time to time in the bylaws but shall never be less than one. The power to adopt, later, amend or repeal by-laws shall be vested in the shareholders of this corporation.

## ARTICLE X - RESTRICTIONS ON TRANSFER OF STOCK

Shares of capital stock of this corporation shall be issued initially to the following persons and in the amount set opposite their names:

Shares held by the initial shareholders listed above may not be resold or otherwise transferred to other persons unless first offered to the remaining shareholder(s) or to this corporation. The price and terms at which, and the time within which, those shares may be offered and sold shall be further specified by written agreement among all of the shareholders of this corporation.

#### ARTICLES XI - MANAGEMENT OF CORPORATION BY SHAREHOLDERS

All corporation powers shall be exercised by, or under the authority of, and the business affairs of this corporation shall be managed under the direction of, the shareholders of this corporation.

#### ARTICLE XII - MEETING BY CONFERENCE TELEPHONE

Shareholders, officers and directors of this corporation may participate in special or regular meetings of said individuals by means of conference telephone as provided by law.

#### **ARTICLE XIII - INDEMNIFICATION**

The corporation shall indemnify an officer, or any former officer, to the fullest extent permitted by law.
