THE UNDERSIGNED, Thomas E. McIntyre, President of Heritage Hotel Corp., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

**ARTICLE FIRST:** The name of the Corporation is HERITAGE HOTEL CORP.

ARTICLE SECOND: ARTICLE III of the existing Articles of Incorporation is hereby amended by deleting the existing ARTICLE III in its entirety and restating it as follows:

## "ARTICLE III - PURPOSE

The corporation is organized solely for the purpose of owning, operating and managing the property known as the Heritage Inn located at 234 3rd Avenue North, St. Petersburg, Florida 33701 (the "Property"), entering into and performing its obligations with respect to any loan secured by a first mortgage lien on the Property (the "Mortgage Loan"), and engaging in any and all activities permitted under the Florida Business Corporation Act which are incidental thereto. Until the Mortgage Loan is paid and satisfied in full, the purposes of the corporation shall not be amended, modified or supplemented in any respect. The corporation shall not engage in any activities other than as permitted hereby."

ARTICLE THIRD: These Articles of Amendment to the Articles of Incorporation shall be effective as of March 25, 1998. The amendment reflected in Article Second above was approved by the Board of Directors and the Shareholders effective as of March 24, 1998.
