ARTICLE 1

NAME AND EXISTENCE The name of this Corporation is KENNETH U. FLOOD, INC., hereinafter referenced as the ("Corporation"), and the Corporation shall have perpetual existence.

ARTICLE 2

ARTICLE 6

INCORPORATOR. The incorporator of this Corporation is Kenneth U. Flood whose business address is 26 Cayman Place, Palm Beach Gardens, Florida 33418.

ARTICLE 7

NUMBER OF DIRECTORS. The Board of Directors of the Corporation shall consist initially of Kenneth U. Flood. Thereafter, Directors shall be elected pursuant to

procedures contained in the Bylaws. Directors, as such shall receive such compensation for their services, if any, as may be set by the Board of Directors at the annual or special meeting. ARTICLE 10

The Corporation shall indemnify, or advance reasonable expenses to the fullest extent authorized or permitted by Florida law, to any person made, or threatened to be made, a party to any action, suit or proceeding by reason of the fact that he/she (i) is or was a director of the Corporation; (ii) is or was serving at the request of the Corporation as a director of another corporation; (iii) is or was an officer of the Corporation, provided that he/she is or was at the time a director of the Corporation; or (iv) is or was serving at the request of the Corporation as an officer of another corporation provided that he/she is or was at the time a director of the Corporation or a director of such other corporation, serving at the request of the Corporation. Unless otherwise expressly prohibited by Florida law, and except as otherwise provided in the foregoing sentence, the Board of Directors of the Corporation shall have the sole and exclusive discretion, on such terms and conditions as it shall determine, to indemnify, or advance expenses to, and person made or threatened to be made, a party to any action, suit, or proceeding by reason of the fact that he/she is or was an officer, employee or agent of the Corporation or is or was serving at the request of the Corporation as an offices, employee or agent or another corporation, partnership, joint venture, thrust or other enterprise, No person falling within the purview of the foregoing sentence may apply for indemnification or advancement of expenses to any court of competent jurisdiction.
