ARTICLE I - NAME

The name of the corporation **LAW OFFICES OF ALFONSO SALCINES, P.A.**, located 2121 Ponce De Leon Boulevard, Suite 240, Coral Gables, Florida 33134.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE


ARTICLE X - INCORPORATOR
