ARTICLES OF INCORPORATION

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of Florida.

ARTICLE I - NAME

The name of the corporation is:

WEST COAST SCHOOL OF BARTENDING INC.

ARTICLE II - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida, including but not limited to the operations of a vocational educational training school, for bartending, as defined in section 246.203 (1), Florida Statutes and upon obtaining the required license from the State Board of Independent Postsecondary Vocational, Technical, Trade and Business Schools intend to commence operations as such.

ARTICLE III - CAPITAL STOCK

This Corporation is authorized to issue 50,000 shares of \$.01 par value stock, which shall be designated as "common Stock". All of said stock shall be payable in cash, property ( real or personal ) or labor or services in lieu thereof at a just valuation to be fixed by the Board of Directors.

ARTICLE IV - VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of outstanding Common Shares.

ARTICLE V - TERM

This corporation shall commence its existence upon filing and exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE VI - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof ( as nearly as may be done without issuance of fractional shares ) at the price at which is offered to others.

No contract or other transaction between this corporation and any other corporation, an no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of this corporation are pecuniary or otherwise interested in, or are directors, or officers of, such other corporation. Any directors individually, or any firm of which any director may be a member, may be a party to, or may be pecuniary or otherwise interested in, any contract or transaction of this corporation provides that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any director of this corporation who is so interested may be counted in determining the existence of a quorum at any meeting of Board of Directors of this corporation which shall authorize any such contract or transaction with like force and effect as if he were not such director or officer of such other corporation, or not so interested.

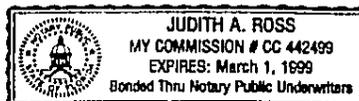
