The undersigned incorporator of this Corporation under Chapter 607, Florida Statutes, as amended, adopts the following Articles of Incorporation.

ARTICLE

The name of this Corporation is: JACOB'S IRRIGATION, INC.

ARTICLE II

The principal place of business of this Corporation shall be 5241 Geneva Way, #108, Miami, Florida 33166.
