The undersigned natural person, for the purpose of forming a corporation under the Florida Business Corporation Act, Ch. 607 Florida Statute (1993), does hereby adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation is SEAGLE INTERNATIONAL, Inc.

ARTICLE II

Nature of Business

The general nature of the business to be transacted by this corporation is Import/Export and any other activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

Shares of Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 (One Hundred) shares of common stock at par value of \$1.00 (one dollar) per share.

ARTICLE IV

Initial Capital
