ARTICLES OF INCORPORATION

Articles subscribers to these undersigned Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is: MARTY'S USED CARS, INC.

ARTICLE II - NATURE OF BUSINESS

The general character, purpose, and nature of business to be

transacted by this corporation is as follows:

(a) To acquire by purchase, lease or otherwise, lands and interest in lands owned, held or occupied by the corporation, buildings or other structures, now or hereafter erected on any lands, and any buildings or other structures, at any time owned or held by the corporation. To buy, sell, mortgage, exchange, lease, hold for investment or otherwise, use and operate, real estate of all kinds, improved, or any right or interest therein.

(b) To acquire, by purchase, lease, manufacture or otherwise,

any personal property deemed necessary or useful, in the equipment, furnishing, improvement, development or management of any property, real or personal, at any time owned, held or occupied by the corporation, and to invest, trade, lease, rent, encumber or dispose of any personal property at any time owned or held by this

corporation.

(c) To carry on in any capacity any business or trade deemed

legal in the State of Florida.

(d) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and to execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate indebtedness as required.

(e) To purchase the corporate assets of any other corporation

and engage in the same or other character of business.

To becomes a partner with any person or persons, corporation, or any other business entity and engage in the same or other or any character of business legal in the State of Florida.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock, to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
