The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation shall be: TOTAL COMMERCIAL POOL AND SPA, INC.

The principal place of business and mailing address of the corporation shall be: 340 Beach Drive Northeast, St. Petersburg, Florida 33701.

ARTICLE II. NATURE OF BUSINESS

The corporation may change the number of its officers and directors at any time by the nomination and election thereof.


