ARTICLE I.

NAME

The name of the Corporation is: C.L. BENT ENTERPRISES, INC.

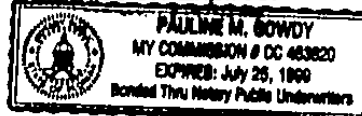
