## ARTICLES OF INCORPORATION

OF

The undersigned does hereby subscribe to acknowledge and fine the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE ONE

The name of the corporation is: AKA INDUSTRIES, INC.

## ARTICLE TWO

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.
