The undersigned subscribers to these Articles of Incorporation, natural persons, competent to contract, hereby form a Corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is: **FLORIDA INTERNET GROUP, INC.**

ARTICLE II. NATURE OF BUSINESS

To establish, maintain, and conduct a business for solicitation of Internet presence providing and Internet publishing for the purpose of advertising and promoting all other legal business endeavors permitted under Florida law.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is **FIVE HUNDRED SHARES (500)** of common stock, each share having the par value of Ten Dollars (\$10.00). The consideration to be paid for each share shall be fixed by the Board of Directors.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this Corporation will begin business is **FIVE THOUSAND DOLLARS (\$5000.00)**.
