FOR
RIDNER SIGNS INC.**

The undersigned acting hereby as Incorporator for the purpose of forming a corporation for profit under the provisions of Section 607, Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be **Ridner Signs, Inc.**

ARTICLE II

The general nature and purposes of business to be transacted, promoted and carried on by the corporation includes but is not limited to the designing, manufacturing and installing of signage and any other activity legally authorized in the State of Florida.

ARTICLE III

ARTICLE IV
