ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation for profit, with the powers, rights, privileges and immunities hereinafter mentioned, and we hereby make subscribe and acknowledge and file with the Secretary of State these Articles of Incorporation; and to that end we do; by and through these Articles, set forth:

ARTICLE ONE NAME

The name of the corporation is:

ARTICLE TWO DURATION

The term of existence of this corporation is perpetual.

<u>ARTICLE THREE</u> PURPOSE

The general nature of the business or business to be transacted by the corporation, which shall include, without limitations, the authority to engage in and transact, within and without the State of Florida or the United States, any and all lawful business or activity permitted under the laws of the United States or of the State of Florida for which corporations may be incorporated under chapter 607, Florida Statutes, is a follows:

(1) To engage generally in the real estate business as principal, agent, broker, and in any lawful capacity, and generally to take, lease purchase, or otherwise acquire, and to own, use, hold (including holding for investment) sell, convey, exchange, lease, mortgage, work, clear, improve, develop, divide, and otherwise handle, manage, operate, deal in and dispose of real estate, real property, lands, multiple dwelling structures, houses, buildings, and other works and any interest or right therein; to take lease, purchase or otherwise acquire and to own, use, hold, sell, convey, exchange, hire, lease, pledge, mortgage, and otherwise handle, and deal in and dispose of, as principal, agent, broker, and in any lawful capacity, such personal property chattels real, rights, easements, privileges, chooses in action, notes, bonds, rights mortgages, and security as may lawfully be acquired, held or dispose of, and to acquire, purchase, sell, assign, transfer, dispose of, and general deal with, as principal, agent, broker, and any lawful capacity, mortgages and other interest in real, personal and mixed properties; to carry on a general construction, contracting, building, and realty management business, as principal, agent representative, contractor, subcontractor and in any other lawful capacity,

- (2) To carry on a general mercantile, industrial investing service or trading business in all its branches, to devise, invent, manufacture, fabricate, assemble, install, service maintain, after, buy, sell, import, export, license and licenser, and licensee, lease as lessor or lessee, distribute, job, enter into, negotiate, execute, acquire, and assign, and assign licensing arrangements, options, franchises, and other rights in respect of, and generally deal in and with, at wholesale and retail, as principal and as sales, business, special, or general agent, representative, broker, factor, merchant, distributor, jobber, advisor, and in any other lawful capacity, goods, warea, merchandise, commodities, and unimproved, fluished, processed and other real, personal, and mixed property of any and all kinds, including services together with the components, resultants and by products therefore; to nequire by purchase or otherwise own, hold, lease, mortgage, sell or otherwise dispose of, creet, construct, make, after, enlarge, improve, and to said and subscribe toward the construction, acquisition or improvements of any factories, shops, storehouse, building, and commercial retail, and service establishment of every character, including, without limitation, all equipment, fixtures, machinery, implements and supplies necessary, or incldental to or connected with, any of the purposes or businesses of the corporation; and generally to perform any and all acts proper or necessary for the purpose of the business; including the ownership and control of the other corporations and serving as partner in partner ships foreign or domestic.
- (3) To apply fio, register, obtain, purchase lease take, licenses in respect of or otherwise acquire, and to hold own, use, operate develop, enjoy, turn to account, grant licenses and immunities in respect of, manufacture under and to introduce, sell, assign, mortgage, pledge or otherwise of, and, in any manner deal with and contract with reference to:
 - (a) inventories, devices, formulas, processes and any improvements and modifications thereof,
- (b) letters, patents rights, patents processes, copyrights, designs, and similar rights, trademarks, trade symbols, and other indications or origin and ownership granted by or recognized under the laws of United States of America or may state subdivision thereof, or of any foreign country or subdivision thereof, and all rights, connected therewith or pertaining thereto;
 - (c) franchise, licenses, grants and concessions.
- (4) To engage in any and all real estate activities both domestic and foreign and to engage in the purchase and safe of all kinds of real estate property.
