This corporation shall have perpetual existence.

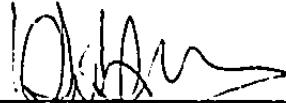

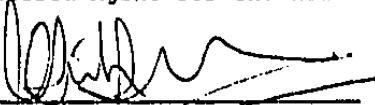
ARTICLE VIII - DIRECTORS

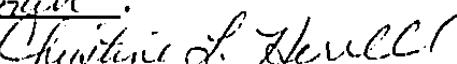

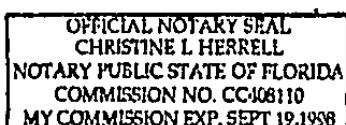
