

ARTICLES OF INCORPORATION
OF

PRIDE (RENTALS) ENTERPRISE, INC.

The undersigned, for the purpose of incorporation under the Florida general Corporation Act, do hereby adopt following articles of incorporation:

ARTICLE ONE
NAME

The name of this corporation is PRIDE (RENTALS) ENTERPRISE, INC.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSE

The general purpose for which the corporation is organized are:

1. To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
2. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

ARTICLE FOUR
CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 1,000. Such shares shall be of a single class, and shall be without par value.

ARTICLE FIVE
REGISTERED OFFICE AND AGENT

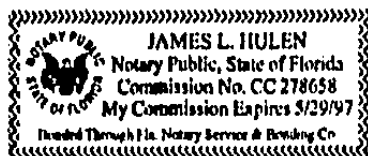
