ARTICLES OF INCORPORATION
OF
RALEIGH SQUARE COMPANY, INC.

96 MAY -6 1996

The undersigned Incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is Raleigh Square Company, Inc.

ARTICLE II

NATURE OF BUSINESS

The corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory, or nation.

ARTICLE III

CAPITAL STOCK

The aggregate number of shares of stock that the corporation is authorized to have outstanding at any one time is:

Common: 10,000 shares

ARTICLE IV

CUMULATIVE VOTING

In all elections for directors, every common stock shareholder shall be entitled to cast as many votes as there are directors to be elected, multiplied by the number of shares owned by the common stock shareholder. The common stock shareholder may cast the whole number of votes for one candidate, or distribute them among two or more candidates as the common stock shareholder may prefer. The candidates receiving the highest number of votes up to the number of directors to be elected will become directors of the corporation.

ARTICLE V

TERM OF EXISTENCE

The corporation is to exist perpetually.

ARTICLE VI
