# ARTICLES OF INCORPORATION OF F. XPRESS, INCORPORATED

36 HAY -7 PH 2: 33

The undersigned, acting as Incorporators of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

## ARTICLE ONE - CORPORATE NAME

The name of this corporation is **F.XPRESS**, **INCORPORATED**. The initial principal office of the corporation is 5009 S. Florida Avenue, Inverness, Florida 34452. The mailing address of the corporation is 402 Temple Street, Inverness, Florida 34452.

# ARTICLE TWO - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all activity or business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE THREE - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of One Dollar (\$1.00) per share. The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable, either in cash, in property, or in shares of the capital stock of the corporation. The shares of the capital stock of the corporation are not to be divided into classes.

#### ARTICLE FOUR - TERM OF EXISTENCE

This corporation shall have perpetual existence, commencing upon the filing of the Articles of Incorporation with the Secretary of State.

# ARTICLE FIVE \* REGISTERED AGENT AND INITIAL REGISTERED OFFICE
