

ARTICLES OF INCORPORATION OF ERICKSON ASSOCIATES, INC.

The undersigned, in order to form a corporation for the purposes hereinafter stated, by and under the provisions of the laws of the State of Florida, does hereby subscribe to these Articles of Incorporation.

5-8-90

Article I - Name

The Name of this corporation is:

ERICKSON ASSOCIATES, INC.

Article II - Duration

This corporation shall have perpetual existence. The corporate existence commences on May 8, 1996.

D. to engage in any or all lawful activity and to institute, participate in and promote commercial, mercantile, financial and industrial enterprises and operations, and for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK
