ARTICLE I - NAME

The name of the corporation is

J and R of GULF BREEZE, INC.

The Principal office shall be: 300 Pensacola Beach Blvd. Ste 4 Pensacola, FL 32561

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State and until such time as it shall be dissolved by law.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of sales and service of marine electronics and any and all other business not unlawful under the laws of the State of Florida or the United States.

ARTICLES IV - CAPITAL STOCK
