# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

# ARTICLE I

# May 6, 1996

# NAME AND BUSINESS ADDRESS

Section 1.1. Name. The name of the corporation is FISHMARK HOLDINGS, INC. The business address of the corporation is 12866 Rabbit Run Lane, Jacksonville, Florida, 32246.

# ARTICLE II

# **DURATION**

Section 2.1. Duration. This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of Florida within five (5) days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

# ARTICLE III

#### **PURPOSES**

Section 3.1. Purposes. This corporation is organized for the purpose of transacting any or all lawful business permitted under the Laws of the United States and of the State of Florida.

#### **ARTICLE IV**

# CAPITAL STOCK

Section 4.1. Authorized Capital. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 10,000 shares of

common stock having a par value of \$.10 per share.

Section 4.2. Restrictions on Transfer of Stock. The shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they may see fit.

# INITIAL REGISTERED OFFICE AND AGENT

Section 5.1. Name and Address. The street address of the initial registered office of this corporation is 4190 Belfort Road, Suite 240, Jacksonville, Florida 32216, and the name of the initial registered agent of this corporation at that address is SUSAN SLAGLE.

# DIRECTORS

Section 6.1. Number. This corporation shall have five directors initially. The number of directors may be increased from time to time by the bylaws, but shall never be less than one.
