ARTICLE (I)

NAME OF CORPORATION

The name of this Corporation shall be:
GENERAL AUTO REPAIR - SALES AND EXPORTS, INC.

ARTICLE (II)

TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE (III)

PURPOSE

The purpose for which this Corporation is formed is to engage in any activities or business permitted under the Laws of the United States and Florida and not limited to general auto repairs, sales and exports.

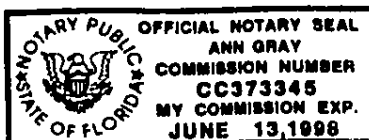
