

The undersigned, for the purpose of forming a corporation pursuant to the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

1. The name of the Corporation is MEDICAL CONSULTING GROUP PROFESSIONALS, INC.

1. The name of the corporation is MEDICAL CONSULTING GROUP PROFESSIONALS, INC.


2. By amendment adopted 8/14, 1996, Section 1 of the Articles of Incorporation is amended to read:
