## ARTICLES OF INCORPORATION The RJ5 Group, Inc.

#### ARTICLE I

The name of the corporation is **The RJ5 Group.** Inc. with principal office at 1016 Dishman Loop, Oviedo, Florida 32765.

#### ARTICLE II

The corporation shall have perpetual existence. The date and time of commencement of corporate existence shall be as of the filing of the Articles of Incorporation by the Department of State, State of Florida.

#### ARTICLE III

The general purpose for which the corporation is initially organized is for the transaction of any and all fawful business for which corporations may be incorporated under Chapter 607, F.S.

#### ARTICLE IV

The corporation shall have authority to issue 50,000 shares of common stock, consisting of one class only, and having a par value of \$1.00 each.

The corporation shall have authority to issue 25,000 shares of preferred stock having a par value of \$1.00 each. The preferred stock shall consist of one series, and the Board of Directors shall have authority to establish additional series or fix and determine the variations in the relative rights and preferences between series, except upon approval of preferred stockholders holding 75% of the issued preferred stock.

The preferred stock shall be entitled to the following rights and privileges:

- (a) Any preferred shares shall be redeemable by the corporation beginning five (5) years after the date of issuance at a price determined by dividing the balance sheet Owners' Equity of the corporation by the total outstanding preferred shares. The decision to redeem preferred shares shall be within the sole discretion of the Board of Directors which shall be authorized to effect a redemption of all or part of the outstanding preferred shares. In the event the Board determines to redeem less than all the outstanding preferred shares, the redemption shall be made on a pro-rata basis from all preferred stockholders.
- (b) The holder of each outstanding preferred share shall be paid an annual dividend of \$0.10, payable monthly. The dividend shall be cumulative.
- (c) The shares of preferred stock shall have preference over any other class or classes of shares as to the payment of dividends.
- (d) The shares of preferred stock shall have preference in the assets of the corporation over any other class or classes of shares, upon the voluntary of involuntary liquidation of the corporation.
- (c) The holders of preferred stock shall be entitled to elect at least 51% of the members of the Board of Directors.
