CERTIFICATE OF ARTICLES OF INCORPORATION
VENDING REPAIR SERVICE, INC.

I, the undersigned, hereby associate myself together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the state providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

Article I

The name of the corporation shall be:
VENDING REPAIR SERVICE, INC.

Article II

This corporation may engage in the activity of vending services or in any activity permitted under the laws of the United States and of this state.

Article III

The amount of the authorized capital stock of this corporation shall be 1,000 shares of One no/100 (1.00) dollar par value common stock which shall be designated as "common shares".

Article IV

The amount of capital with which the corporation will begin business shall not be less than \$1,000.

Article V

The term for which this corporation shall exist is perpetual unless dissolved by law.

Article VI

The corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time by the by-laws but shall never be less than one.

Article VII

The place of business as well as the principal office of this corporation shall be 10281 N W 53rd Street, Sunrise, Fl 33351 and may have such other places of business in the state of Florida as the nature and progress of the business from time to time shall render necessary or desirable. Said corporation shall also have the power to conduct its business outside the state of Florida and/or in any and all several states and territories and districts of the United States, and in any and all foreign countries, and may have one or more offices, in any of the said business.

Article VIII

The street address of the initial registered office of the corporation shall be 10281 N W 53rd Street, Sunrise, Fl 33351 and the name of the initial registered agent of the corporation shall be Julian Itzkowitz.

Article IX

The name of the first board of directors, who, subject to the provisions of these articles, for the first year of the corporation's existence or until their successors are duly elected.



Article XII

The corporation may not issue any shares of its capital stock to anyone other than an individual who is duly licensed or otherwise legally authorized to render the same services as those for which the corporation is incorporated. No shareholder of the corporation may sell or transfer his shares in the corporation except to another individual who is eligible to be a shareholder of the corporation. No shareholder of the corporation shall enter into a voting trust agreement or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of his shares of capital stock of the corporation.
