**ARTICLE I**

The name of the corporation is: **SOUTH VENICE AUTO REPAIR, INC.**

**ARTICLE II**

The period of its duration is perpetual.

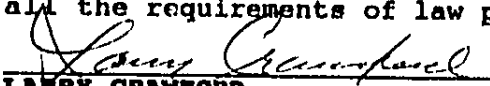
