The name of this corporation shall be C. & S. PLASTERING & STUCCO, INC.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The primary purpose of this corporation shall be to engage in the general PURCHASES BUILDING, MATERIAL AND SUPPLIES ENTERING INTO CONTRACTS relating to operation of a PLASTERING AND STUCCO CONTRACTOR and the transaction of any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.
