We enclose herewith the "Second Notice" of Annual Report for the above-named corporation together with a check for \$150.00.

The corporations never received the original annual report and, as a result has been charged the additional \$400.00. Unfortunately, our client is looking to place the blame on our firm for not following up to see that the report was timely filed. Some of our clients complete and mail the annual report by themselves, while others forward the reports to our office for completion which gives us the opportunity to see that the reports are timely.

Each year one or possibly two clients receive the "Second Notice" and we usually find that they had put aside the first notice and merely overlooked the filing date, whereby the additional charge was paid. However, for this year, we have at least nine (9) clients who swear that they never received the first notice. At first, we were skeptical when the first two clients came forth. But since the list has grown to nine (9) clients, it appears that there may have been a mix-up in Tallahassee whereby some corporations were not mailed the Annual Reports.

It is certainly not unreasonable to realize that a taxpayer who does not receive the Annual Report, may not be aware of the requirement to mail by April 30th in order to avoid the additional charge. We therefore request that your office reconsider the abatement of the additional charge in this instance.
