**ARTICLES OF INCORPORATION
OF
ONE DELTA KILO, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is **ONE DELTA KILO, INC.**

ARTICLE II

The existence of the Corporation shall begin **five (5) business days prior to filing the Articles.**

ARTICLE III
