ARTICLE I - NAME

The name of this Corporation is Precision Auto Repairs Plus, Inc. and the address is 870 E. Semoran Boulevard-436, Apopka, Florida 34703.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS

This Corporation may engage or transact in any or all activities or businesses permitted in the laws of the United States of America and the State of Florida.

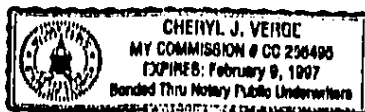
