ARTICLE I: NAME

The name of this corporation is **MAINTCO SERVICES, INC.**

ARTICLE II: NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the State of Florida or any other state and of the United States.

ARTICLE III: CAPITAL STOCK

This corporation is authorized to issue ten thousand (10,000) shares of common stock, which shares shall be and hereby are designated as "Common Shares".

The name and address of the Incorporator of this corporation is Mauro Page, 159 LaPasada Circle, Ponte Vedra Beach, Florida 32082

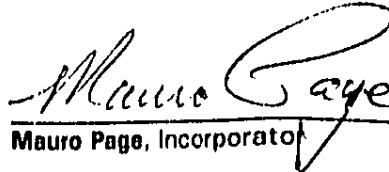
ARTICLE VIII: BYLAWS
