# ARTICLES OF INCORPORATION OF CHRISTIAN CARE CARRIER, INC.

I, the undersigned subscriber to the Articles of Indersignation, natural persons, competent to contract, hereby form a corporation under the laws of the State of Florida.

#### ARTICLE I

The name of the corporation shall be CHRISTIAN CARE CARRIER, INC. Its principal place of business shall be 1003 1st Street East, Bradenton, Manatee County, Florida.
