ARTICLE I - NAME

The name of the corporation is TREACO PEST CONTROL. INC.

### ARTICLE II - PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States of America and of the State of Florida. Specifically, the corporation may act as a general or limited partner in a limited partnership.

### ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 1,000,000 shares at one tenth of one cent (.001) par value common stock.

## ARTICLE IV - PRE-EMPTIVE RIGHTS

Every shareholder, upon sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

### ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The corporation, and subject to the priority of the corporation, the remaining shareholders of the corporation shall have a preference in the purchase of any shares of the capital stock of the corporation, and any attempted sale of such shares of stock in violation of this provision shall be null and void. In case a stockholder, his personal representative, heir, devisee, legatee, pledgee, assignee, receiver, trustee in bankruptcy or any other person holding under or in privity with any stockholder, desires to sell his shares of stock, he shall file notice in writing of such intention with the Secretary of the corporation, stating the terms of the bona fide offer which he has received, and unless the terms of such offer are accepted by the corporation within ten (10) days, it shall be deemed to have waived its privilege of purchasing. The Secretary of the corporation shall mail a written notice to all of the remaining stockholders, by certified mail, return receipt requested, and unless the terms of such bona fide offer are accepted by any or all of the other stockholders within ten (10) days from the date of mailing such notice, they should be deemed to have waived their privilege of purchasing, and the stockholder or the person in privity with him desiring to sell shall be at liberty to effect a sale upon the terms of such bona fide offer. the corporation, stockholder may cause the remaining or stockholders, to waive their privilege of purchasing until such stockholder has received a bona fide offer for the purchase of such shares. Neither the corporation, nor the remaining stockholders (collectively), may exercise their privilege of purchasing as to any shares of stock less than the total number of shares involved in such bona fide offer.

### ARTICLE XII - INDEMNIFICATION

The corporation shall indomnify any officer or director or any former officer or director, to the full extent permitted by law.

### ARTICLE XIII - AMENDMENT

This corporation reserves the right to smend or repeal any provisions contained in these Articles of Incorporation, or any amended hereto, and any right conferred upon the shareholders is subject to this reservation.
