The name of the Corporation is:

The Corporation's initial Registered Agent and Registered Office in the State of Florida are:

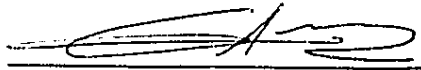

ARTICLE X.

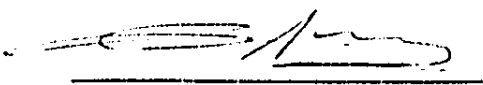

The members of the Board of Directors may participate in meetings of the Board of Directors by means of conference telephone as provided by law.

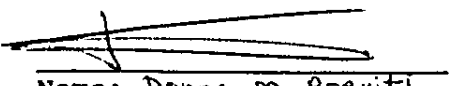
