ARTICLE I. NAME

The name of the corporation is WINCOM COMPUTER SYSTEMS, INC.

ARTICLE II. PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III. CAPITAL STOCK

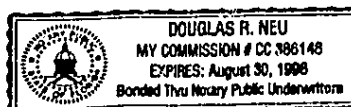
