ARTICLES OF INCORPORATION

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME AND ADDRESS: The name of the Corporation is: CHRISTOPHER NICODEMUS, INC. and its address is 1093 A1A Beach Blvd, Suite 223, St. Augustine Beach, Florida 32084.

ARTICLE 2. DURATION: This Corporation shall have perpetual existence.
