The undersigned incorporator, for the purpose of TAKORMANGUEATLUMUA corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I

# NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION

The name of the Corporation is YOGASHVER, INC. The principal place of business of the Corporation is 988 WESSON DR. CASSELBERRY, FL. 32707. The duration of the Corporation is perpetual.
