ARTICLE I
NAME AND ADDRESS

The name of the corporation is DORIC DESIGNS, INC. The address of the corporation shall be 531 West 30th Street, Miami Beach, Florida 33140.

ARTICLE II
DURATION

This corporation shall have a perpetual existence commencing upon filing of the Articles of Incorporation with the Secretary of State.

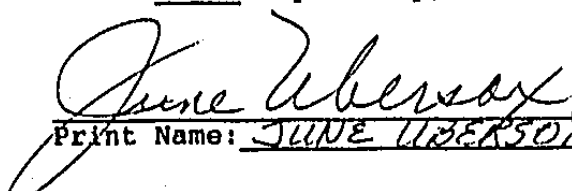

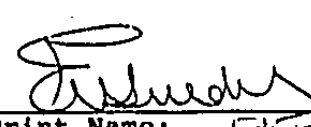
