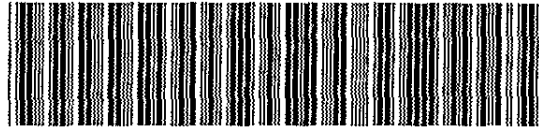

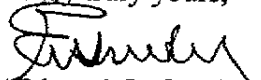

RESOLVED, that Article I of the Articles of Incorporation of the Corporation be and hereby is amended to read as follows:

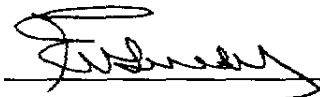
ARTICLE I

The name of this Corporation shall be EGPS, Inc. The address of the corporation shall be 3750 Royal Palm Avenue, Miami Beach, Florida 33140.

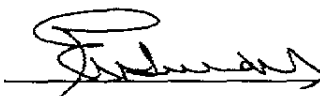
Said Amendment to become effective upon the filing of the Articles of Amendment with the Secretary of State, State of Florida.

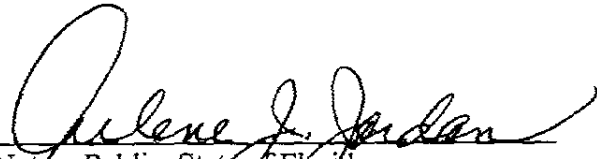

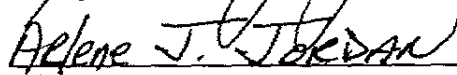
