Pursuant to the provisions of §607.1006 of the Florida Business Corporation Act, DRS. AIRALA LASER & CATARACT INSTITUTE, P.A., a Florida professional association (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is DRS. AIRALA LASER & CATARACT INSTITUTE, P.A. (hereinafter called the "Corporation").
2. The Articles of Incorporation were filed on May 6, 1996 and Restated on June 25, 2003, under document number P96000041958 (the "Articles of Incorporation").
3. Article III of the Corporation's Articles of Incorporation is deleted in its entirety and replaced with the following new Article III:

**"ARTICLE III  
CAPITAL STOCK**

This Corporation shall have the authority to issue One Hundred (100) shares of Common Stock having a par value of \$1.00 per share. Each issued and outstanding share of common stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders."


4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged.
5. The amendment made herein to the Articles of Incorporation of the Corporation was adopted by the written consent of the sole Shareholder, the number of votes cast for the amendment was sufficient for approval, and the Directors of the Corporation on the date of these Articles of Amendment, pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act.
6. The effective date of this Amendment shall be upon the filing of these Articles of Amendment.
