OF

THE UNDERSIGNED Incorporator, for the purpose of forming a Corporation for Profit under the Corporation Act of the State of Florida, does hereby certify as follows:

ARTICLE I: NAME

The name of the corporation is: ENDEAVORS IN NEUROLOGY, INC.

ARTICLE II: PURPOSE

This corporation is organized for the following purposes: To promote Medical Research and to engage in any activity or business which is permitted under the laws of the United States and of the State of Florida.



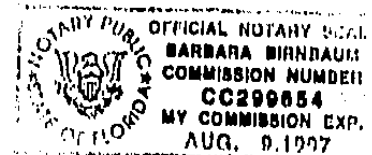
