ARTICLES OF INCORPORATION
OF
Command Theatrical Performances, Inc. 96 MAY 10 PM 1:09

ARTICLE I - NAME

The name of this Corporation is Command Theatrical Performances Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing immediately.

ARTICLE III - PURPOSE

The Corporation may engage in any activity permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
