Articles of Incorporation for the purposes of establishing a
corporation for profit under the "Florida Corporation Act".

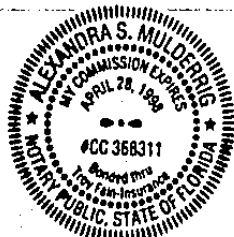
