**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is C. M. ACEVEDO CONSTRUCTION CO., INC. and its principal place of business shall be located at 1551 Cheyenne Ct., Tallahassee, FL 32301.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue One Hundred (100) shares of common stock at One Dollar (\$1.00) par value, which shall be designated as "Common Shares."
