NAME



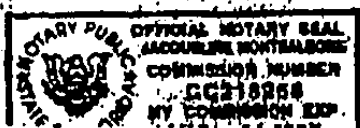
