ARTICLE I - NAME

The name of this corporation is DESIGN AND COMFORT FURNITURE,

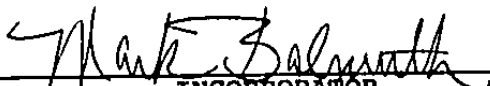
The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.
